PROFESSIONAL UNCONTROLLED RECIPIENTS - If the Uncontrolled Recipient does not qualify as a Nonprofessional and is required to login to the Vendor's Display Service before each session, the Subscriber may be reported by the Vendor as a Controlled Subscriber. No redistribution is permitted by such Subscribers, and use is restricted to one Subscriber. Professional Uncontrolled Recipients may not use third party software to qualify for this exception.

\*\*\*. NONPROFESSIONAL UNCONTROLLED RECIPIENTS - If an Uncontrolled Product Recipient qualifies as a Nonprofessional, the Subscriber may be reported as a Nonprofessional Subscriber and may be charged the Nonprofessional rates. To receive the Nonprofessional rates, Vendors are to separately identify and submit Detail Usage Reports listing all Nonprofessional Uncontrolled Recipients. No redistribution is permitted by such Subscribers, and use is restricted to one Subscriber.
